4. Bid Submission:

Sealed quotations are to be submitted in two separate envelopes super-scribed as: Envelope-A: Technical Quote and Envelope-B: Financial Quote.

For details see ANNEXURE– I. Both these envelopes should be enclosed in an outer envelope, which should also be sealed and clearly mentioning on top right corner of the envelope "12V/26AH SMF Battery" and "Repair of 1 Online 10KVA EMERSON UPS"

Envelope-A: Technical Quotation: The following details are to be enclosed:

Qualification Criteria:

- 1. Bidder must have to provide their details as per Appendix-I.
- 2. A compliance chart based on the specifications as per the NIQ
- 3. List and addresses of organizations where similar items have been supplied in last 3 years in India.
- 4. Catalogue of the item
- 5. The bidder should have been registered with State Goods and Services Tax (GST). Copy of such certificate including Self-attested copy of PAN card shall be enclosed as a proof.
- 6. Registration Certificate of bidder under any suitable act e.g. shop and Establish Act, Company Act, Partnership Act etc. Copy of such certificate shall be enclosed as a proof
- 7. Bidder should have a functional registered Office within 100 KM radius of Consignee Location.
- 8. Bidder should have a proper service set up with minimum two Technicians. Valid Proof of appointment to be attached.
- 9. The bidder Bids are invited from the eligible and experienced OEM (Original Equipment Manufacturer) or OEM authorized dealers/suppliers for purchase of batteries along with duly furnished information, Quotation fee and EMD.
- 10. The quoted batteries should be of national and international reputed brands such as Exide, Panasonic, quanta, Amaron or equivalent brand with following specification:
 - 26AH/12V SMF Battery (Quantity; 40)
- 11. The bidder should not be blacklisted by any Government or Semi Government organization or Govt. Autonomous Bodies. The bidder must submit an affidavit/Signed undertaking for not blacklisted by any other Government Organization.
- 12. Sole agency certificate on the letterhead of the principal company if quote is for imported material to be supplied through Indian Agent, or if quotation is from an Indian Agent.
- 13. **Period of Warranty:** The bidder must provide comprehensive onsite warranty for minimum 3 years from the date of installation of batteries. In case of any defect in supply or any performance related problem observed during warranty period, the bidder shall have to replace the defected battery with new battery of same technical specification without any additional cost to the purchaser. Further, any complaint shall be attended within a response time of 48 hours on 24X7 basis.

- 14. Work specifications: The successful firm is required to install the new batteries. No assistance from the department will be provided in this regard. The bidder has to bring his own vehicle for lifting the items and have to employ his own labour, bags and other items as required for packing and lifting of the materials. No assistance will be rendered in this regard by the tenderer. The bidder will be responsible for cleaning the area from where the batteries are lifted.
- 15. Tender fee: The bidder has to submit Rs.1000/ as non-refundable tender fee in the form of Bank Draft, in favour of "COMMISSIONER, STATE COMMON ENTRANCE TEST CELL, MS.Mumbai", payable at Mumbai or RTGS/NEFT in the account no. 35415981641, IFSC Code SBIN0000300, State Bank of India, Mumbai Main Branch (00300) Mumbai.
- 16. Earnest Money Deposit (EMD): Bidder EMD of Rs.5,000/- (Rupees Five Thousand Only) is to be deposited through NEFT/ RTGS/ Demand Draft before closing of bid which is refundable after completion of the tender procedure. EMD may be deposited through RTGS/NEFT in the account no. 35415981641, IFSC Code SBIN0000300, State Bank of India, Mumbai Main Branch (00300) Mumbai. The EMD may also be paid through demand draft in favour of 'COMMISSIONER STATE CET CELL MAHA STATE" payable at Mumbai. However, earnest money will be forfeited in case of bidder withdraws or modifies the offer after opening the tender document.
- 17. Security Deposit: Successful bidder has to submit 3% of purchase order as a Security Deposit in the form of Bank Draft in favor of "COMMISSIONER, STATE COMMON ENTRANCE TEST CELL, MS.Mumbai", payable at Mumbai OR NEFT/RTGS in the account no. 35415981641, IFSC Code SBIN0000300, State Bank of India, Mumbai Main Branch (00300) Mumbai. The amount of security deposit will be refunded after three years of installation. But the security deposit will be forfeited if, Successful bidder fails to supply the items within the delivery period and/or supplier fails to comply specifications of battery and/or supplier is not providing satisfactory post sale services and support or fail to replace the defective batteries before warranty period.
- 18. Bidder has to submit the tender documents as per the checklist (Appendix-III).
- 19. The bidder should submit the envelope containing signed hard copy as per checklist (Appendix III) along with forwarding letter (Appendix IV), Declaration Form V and VI. Envelop should marked as "Quotation for SMF Batteries" and it must reach to the Commissioner, State Common Entrance Test Cell, 8th Floor, New Excelsior Building, A.K. Nayak Marg, Fort, Mumbai – 400 001 (Maharashtra) on or before prescribed date and time given in tender notice. The tender received after this will not be considered.
- 20. Bids once quoted can't be changed.
- 21. The prescribed configuration is not mandatory. Higher configuration or latest model will also be permitted.
- 22. The CET CELL may place repeat orders against the acceptance of tender within a period of validity, subject to the same terms and conditions originally provided in advertised tender and selected bidder shall accept the same.
- 23. The Quotation received after due date will not be considered
- 24. The supply must be within the delivery period mentioned in the purchase order; otherwise the order will be automatically cancelled. If any technical reason for delay, consent of purchaser is required.

25. Inability for the supply of goods within the stipulated period and as per the specification by the party after placement of an order will lead to forfeiture of tender deposit.

26. The right to accept or partially accept or to reject the offer is reserved, and cannot be challenged.

- 27. Once offer rejected, there will not be any kind of reconsideration for inclusion in the contract.
- 28. In case of any dispute, decision of Competent Authority, shall stand final.
- 29. The jurisdiction for any legal dispute shall be Mumbai court only.
- 30. If any of the required information is missing, the bid will be rejected straight away. If any kind of malpractice found regarding the details submitted by the bidder at any stage of procedure, then the bid will be immediately rejected and the party will be blacklisted for future endeavours.
- 31. Amendment of bidding documents (corrigendum), at any time prior to the deadline for submission of bids, CET CELL may, for any reason, whether its own initiative or in response to the clarification request by a prospective bidder, modify the bidding documents. The corrigendum will be published on website http://www.mahacet.org only. In order to allow prospective bidders reasonable time to take into consideration the amendments while preparing their bids, at its discretion, CET CELL may extend the deadline for the submission of bids.
- 32. CET CELL reserves all rights to cancel the part or whole tender without giving any reason.
- 33. The supplier should be able to supply the quoted material within seven days of date of purchase order.
- 34. If some specifications are not being met, deviations may be clearly stated. In the unlikely event that none of the vendors are able to meet all the specifications, the committee reserves the right to waive or relax any of the requirements at the technical evaluation stage.
- 35. The successful tenderer(s) shall submit the following documents within a maximum of 02 (Two) days from the date of placement of the Purchase order.
 - a) Duplicate copy of the Purchase Order duly signed and stamped by the tenderer as a token of acceptance of the order.
 - b) Security Deposit as detailed Terms and Conditions (In case it is not deposited, the same will be deducted from the bills payable to the agency. In such event, EMD will form part of the Security Deposit).

Envelope-B: Financial Quote: The following details are to be enclosed:

- 1. Bidders must have to quote their supply price in specified format (Appendix-II)
- 2. The GST charges are applicable on the price after discount. No other charges will be acceptable.
- 3. Prices should be quoted State CET CELL, Mumbai.
- 4. Bid price to include all cost components : Supply, Installation ,Testing and Commissioning of Goods.
- 5. The prices quoted must include charges of delivery at CET CELL Mumbai.
- 6. State CET CELL, Mumbai reserves the right to cancel any or all quotations without assigning any reason thereof. State CET CELL does not encourage any advance payment and payment will be made after delivery and successful installation.

5. Delivery Terms and Liquidated Damages/Punitive deduction:

he Selected bidder shall deliver and install all the batteries and repair the online UPS at the elivery location as per specification above within 7 days after award of contract. For delays, he applicable rate is 0.5% per week and the maximum deduction is 5% of the contract price.

6. Validity Of Quotation:

Quotation shall remain valid for a period not less than 60 days after the deadline date specified for submission.

7. Evaluation of Quotations:

State Common Entrance Test Cell will evaluate and compare the quotations determined to be substantially responsive i.e. which are properly signed; and conform to terms and conditions, and Specifications.

8. Award of Contract:

- a. State Common Entrance Test Cell will award the contract to the bidder whose quotation has been determined to the substantially responsive and who has offered the lowest evaluated quotation price.
- b. Notwithstanding the above, State Common Entrance Test Cell reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
